

Tariffs for maintaining a settlement account in the currency of the Russian Federation (the tariff plan «Moscow»)

| 1 | Opening of a bank account in the currency of the Russian Federation | - a fee is not charged |
| 2 | Trade finance (letters of credit) | - by agreement of the parties |
| 3 | Opening and maintenance of the transaction passport | - 0.15% of the amount |
| 4 | Conversion | - 0.5% of the amount |
| 5 | Intrabank transfers | - a fee is not charged |
| 6 | Payments in the Russian currency | - RUR 25 per each payment document on condition of using the system Bank-Client*. |
| 7 | Express payment (via BEBP) | - RUR 300 per document |
| 8 | Processing of payment documents submitted on paper media | - RUR 150 for each payment document |
| 9 | Crediting of funds to the account | - a fee is not charged |
| 10 | Withdrawal of the transfer order upon the client's application | - RUR 200 per document |
| 11 | Execution on the same day of the transfer order submitted to the Bank after the cut-off hour (from 5 p.m. to 7 p.m.) upon the client's application and with the Bank's consent | 0,1% of the document amount but not less than RUR 200 and not more than RUR 5,000 |
| 12 | Notice of payment order receipt | - RUR 300 per document |
| 13 | Transfer of fund balances when closing the account to the client's account with another credit institution | - RUR 200 |
| 14 | Transfer of out-of-area payments in the Russian currency by telegraph | As per the tariffs of the Bank of Russia for the telegraph costs |
| 15 | Interest accrual to balances of the ruble account | - not accrued |
| 16 | Payment of cash funds | - up to RUR 600,000 - 1% of the amount; - from RUR 600,001 up to RUR 3,000,000 - 2% of the amount; - over RUR 3,000,001 - 10% of the amount; |
| 17 | Payment of cash funds for salaries, travel expenses and allowances (symbols 40,42,50) | - 0.5% of the amount |
| 18 | Collection | - under additional agreement |
| 19 | Acceptance of cash funds to the bank's counter | - 0.3% of the amount |
| 20 | Maintenance of a bank account in the currency of the Russian Federation | - RUR 600 per month |
| 21 | Installation of the Bank-Client system | - RUR 2,500 non-recurrent |

| 22 | Issue of a check-book | - a fee is not charged |
| 23 | Visit of a specialist to maintain the Bank-Client system | - RUR 1,500 per visit |
| 24 | Preparation of account statements | - RUR 150 per statement |
| 25 | Sending to another credit institution a specification or a request with regard to a payment | - RUR 300 |
| 26 | Provision of a statement with applications or an extended statement of the client's accounts, upon the client's request (for a period not exceeding 2 months from the date of the request) | - RUR 30 per sheet |
| 27 | Provision of a statement with applications or an extended statement of the client's accounts, upon the client's request (for a period exceeding 2 months from the date of the request) | - RUR 200 per sheet |

* Except for the payment documents providing payments to the budget and extrabudgetary funds.

The tariffs can be unilaterally revised by the Bank upon the change of conditions of the respective market segment or conditions of servicing the Bank by the Bank of Russia.
